#### RESEARCH STATEMENT

The core of my scholarly interests is the intersections of health care, public policy, and social inequality. What unifies my research is exploring, usually by collecting and analyzing original data, how health care systems respond – and fail to respond - to the health needs of socially disadvantaged populations.

## Preventing cancer among high-risk women

Since arriving in the OSU College of Public Health, the bulk of my research has focused on understanding how diverse women at high risk of breast or ovarian cancer make decisions about managing those risks. Initially funded by a 5-year K01 grant from the National Cancer Institute and now unified under the umbrella of the *Daughter Sister Mother Project*, my work fills critical gaps in the existing body of cancer prevention research by (a) aiming to understand experiences and needs of the full range of high-risk women – not just *BRCA* mutation carriers or those in high-risk clinical care, (b) prioritizing women's own complex, real-world approaches to cancer risk and risk management instead of narrower, medically-oriented questions about those women, and (c) documenting and explaining racial, socioeconomic, and other disparities in the dynamics and outcomes of risk-related decision making.

This research trajectory began with a substantial qualitative inductive study of African American and White women at elevated risk for breast cancer. Peer-reviewed articles published from this work establish that women's experiences with the cancers of loved ones affect their own prevention decisions, that the psychosocial challenges of oophorectomy differs for women undergoing that surgery for cancer prevention vs. other purposes, and that there are substantial racial disparities in women's access to prevention-related information. Additional empirical papers are currently under review about chemoprevention awareness and decisions among eligible women, about the full range of racial differences in decision-making dynamics, and about the impact of financial constraints on decision making. Additional manuscripts in development for submission to peer-reviewed outlets in the next year explore the role of romantic partners in prevention decision making, the role of risk-specific social support in

coping with risk, the impacts of patient-provider relationships on women's ability to cope with breast cancer risk, and the overarching dynamics of risk-management decision making. I am the first or senior author on all these papers, which have also generated co-authoring opportunities for multiple graduate students and members of my research staff.

These research products have garnered substantial public and scholarly attention: I have presented multiple invited seminars at OSU venues and at City of Hope Comprehensive Cancer Center in Los Angeles; a review article published in 2017 has already been cited in 15 published articles; abstracts have been selected for "Top Abstract" or oral presentation recognition; and two publications have generated mainstream media attention. My article published in *Ethnicity & Health* resulted in interviews with *BBC World News Radio*, *NPR's InfoTrak*, and other radio shows, as well as print, online, and local TV coverage, and is rated among the top 5% of all research outputs scored by altmetric.com for media impact.

In the second phase of this project, conducted over the past two years, our *Daughter Sister* Mother team designed and collected a large dataset that will enable us to test a range of novel hypotheses developed from the initial inductive research. To achieve this, we developed and tested quantitative survey items to operationalize concepts generated by the qualitative interview-based study, and constructed an instrument to collect data from White and African American women at high risk for breast cancer. Data collection was completed in August 2019, yielding an unusually large sample of 717 high-risk participants, half of whom come from the rarely studied non-clinical high-risk population. Including a much higher proportion of non-White participants (35% African American) than any other quantitative dataset in this area of study, ours is uniquely positioned to address questions about racial disparities related to riskreduction dynamics. We have begun analyzing these data, and are focusing first on writing empirical papers about (a) the unique nature of our study design and contributions of the dataset itself, (b) modeling breast cancer risk using a population-based sample, (c) extent to which high-risk women are aware of and use risk-reduction options, and (d) racial disparities in risk-reduction awareness and use. We also plan to publish papers about the methods we developed to resolve problems involved in collecting a non-clinically-focused sample, about the applicability of the precaution adoption process model to coping with cancer risk, and other topics.

Since 2017, I also launched four new projects stimulated by the findings reviewed above. First, I have conducted two pilot studies on the role of social support and support groups in nurturing health-protective decisions among women at high risk of breast cancer. Based on these, I submitted an R01 application (National Cancer Institute, June 2019) to study risk-related social support systematically among White, African American, and Hispanic women in four U.S. regions. Although not yet funded, this application resulted in a subsequent Cancer Control Program Seed Grant, which will fund preliminary work to strengthen a revised R01 application. Second, building on our findings about the importance of primary care providers in women's ability to obtain and process risk information, I have obtained a 2-year grant from the Spielman Fund (OSUCCC-James) to launch a new project investigating the impact on patients and providers of risk assessment through regular mammogram screening. Third, I am beginning a study among Latinas and Asian American women at high risk for breast cancer that will mimic the foundational qualitative work we have already done with African Americans and Whites. Funded by the Coca Cola Critical Difference for Women Research Grant, this pilot work will be facilitated by my collaboration with researchers at City of Hope Comprehensive Cancer

Center in Los Angeles. Finally, I am designing – in conjunction with OSUCCC's High Risk Breast Program – one of the first-ever cohort studies of high-risk women in clinical care, to study decision making and psychosocial health over time.

## Comparative HIV/AIDS policy

Before embarking on breast cancer prevention work, my primary line of research involved a large-scale comparative study of HIV/AIDS policy in the United States and the United Kingdom since the early 1980s. This multi-method research involved collecting more than 200 key informant interviews with policy makers and advocates in both countries, over 20,000 reports from daily newspapers since 1989, and an extensive compilation of additional historical data. Since joining CPH I have published two articles based on this work – in Journal of Health Politics, Policy, and Law and Social History of Medicine. These articles supplement prior book chapters published in two edited volumes, one of which won a Best Paper Award from the Sociologists' AIDS Network. I intend to return to this topic in about 2 years, and to complete my book manuscript. Tentatively titled Answering AIDS: The United States and the United Kingdom Confront a Health Policy Crisis, the book argues that neither institutional nor cultural explanations adequately account for distinct British and American policy trajectories. Instead, Answering AIDS advances an integrated model of health policy-making that explains treatment, prevention, and research policies as products of the patterned and interdependent influences of social and political institutions, circulating discourses, and political mobilization. Editors at several university presses (including Stanford University Press and University of Minnesota Press) have expressed substantial interest in the book. I have also published three well-cited theoretical articles on the influence of ideas on policy making in and beyond the health arena.

# Collaborative projects

Finally, I maintain ongoing collaborations with several research teams. I lead all qualitative components of a major 3-year PCORI-funded project (Project PI: Gary Franklin at University of Washington, OSU PI: Thomas Wickizer) titled, "Comparative Effectiveness of Two State Payer Strategies to Prevent Unsafe Opioid Prescribing and Improve Outcomes for Injured Workers with Musculoskeletal Injuries and Pain." I also lead qualitative data collection and analysis work for a Pelotonia-funded project (PI: Clara Lee) that uses an original, patientcontrolled method of data collection to study communication between breast cancer patients and their physicians about contralateral prophylactic mastectomy. My ongoing work with collaborators at OSU and elsewhere on a financial effects of cancer diagnoses have so far yielded one paper based on Women's Health Initiative data (Cancer Medicine, first author Theresa Hastert). I have also been working with a large cancer health equity team at OSU (PI: Electra Paskett) to develop "Turning the Page on Breast Cancer" – a major new funded project to improve high-risk identification and risk-reduction education among African American women in Ohio. This same cancer health equity is simultaneously working to build active community-based partnerships with African American communities in Columbus, and I am helping lead this effort. Finally, with OSU collaborators in Biomedical Sciences and Clinical Genetics, I have recently collaborated on a R01 Cancer Health Disparities Supplement (PI: Jeffrey Parvin; under review Spring 2020) aiming to improve the capacity of African American-serving primary care providers to convey genetic information to patients.
