

# 2023-2024 Curriculum Guide for PhD degree program with a specialization in HEALTH BEHAVIOR AND HEALTH PROMOTION

The Doctor of Philosophy (PhD) degree requires a significant program of study and research that qualifies the recipient to conduct independent high quality research and communicate complex information in public health. In addition, the PhD graduate will contribute to the advancement of the field of knowledge. The emphasis is on mastery of the field and particularly on the acquisition of research skills as a basis for original work.

Students pursuing the PhD degree complete didactic and research courses. In addition, PhD students must successfully complete and pass a Dissertation Proposal Defense, a PhD Candidacy Exam, Dissertation and Final Examination. Due to the expanded depth and scope of content and research, it typically takes a minimum of four years to complete the program requirements to earn the PhD degree. Graduates are prepared for teaching/research faculty positions in higher education and other positions in various public and private sectors.

Students admitted to the PhD degree program are assigned a faculty advisor who will provide guidance throughout the program. This document serves as a resource to be used by the student and the advisor in planning a program with a specialization in Health Behavior and Health Promotion (HBHP). #### **PROGRAM OF STUDY**

The PhD program requires a minimum of 80 credit hours or 50 credit hours beyond a master's degree. With approval of the student's advisor and Advisory Committee, up to 30 credit hours of appropriate master's level course work can be counted toward the PhD. Additional requirements for courses and distribution of credit hours are provided below. Students should work closely with their advisor to develop a tentative curriculum plan during the first semester of their enrollment. In collaboration with their advisor, students are encouraged to form their Advisory Committee during their first year in the PhD program.

# Minor Cognate Field (12 credit hours)

Additional credit hrs are required in a minor cognate field that is relevant to the student's research interests. Depending on the student's interests, the minor cognate area may occur within the College of Public Health (e.g., biostatistics or epidemiology) or within other disciplines (e.g., sociology, disability studies, sexuality studies). Students select their minor cognate area and courses with Advisory Committee approval.

Note that a maximum of 20 credit hours of dissertation work can be counted toward the degree.
